IMPORTANT! Chapter Membership Requirements: You must be at least 18 years of age. You must also be a member in good standing of the national CPSA organization to be a member of a local district chapter. Visit www.cpsa.org for details on joining or renewing your national membership.

- **Chapter Dues:** Annual DC 201 chapter dues are \$20.00. Dues paid after the new membership year begins on November 1 are not prorated.

- **Renewals:** Your membership is valid from November 1 to October 31. However, you may renew as early as September 1 for the year that begins on November 1. Memberships lapse March 31.
