

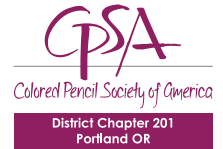

ELIGIBILITY TO ENTER

- Current members of Colored Pencil Society of America District Chapter 201 Portland, OR (CPSA DC 201)
- Current members of Oregon Society of Artists (OSA)

DATES

Entries Open: May 12–June 27, 2019
Art take-in: Thursday, June 27 • 10:00 a.m.–4:00 p.m.
Friday, June 28 • 10:00 a.m.–1:00 p.m.
Installation: Saturday, June 29 • 1:00–4:00 p.m.
Reception: Sunday, June 30 • 1:00–4:00 p.m.
Art pick-up: Saturday, July 27 • 1:00–4:00 p.m.
Monday, July 29 • 1:00–4:00 p.m.

HOW TO ENTER

- Entry fee is \$25 for one or two entries, \$35 for three entries.
- To register and pay for your entry, call Emily Fox/OSA at 503-228-0706.
- Follow instructions on OSA website to download and complete the **OSA Art Show Release Form** and bring it when you deliver your paintings.



ARTIST PARTICIPATION

- This is an open (non-juried) show.
- Artist must be a member of either CPSA DC 201 or OSA.
- Artist must deliver and retrieve artwork during designated art take-in and pick-up hours.
- Artist agrees to **gallery sit for one three-hour period** during the run of the show. If artist lives outside Portland area and unable to gallery-sit, artist will be charged a \$10 fee. Gallery hours are Monday–Saturday, 1:00–4:00 p.m.
- **Place a label on the back of your artwork** with your name, title of work, and email address.
- CPSA DC 201 must provide two volunteers on each take-in day to assist with receipt of artwork. Let Ellen White know if you would like to volunteer.

ARTWORK REQUIREMENTS

- Artists may enter up to 3 paintings.
- There is no age limit for paintings.
- Paintings must be matted, framed, and ready to hang using D rings mounted 4 inches from the top of frame with wire that is tight enough to not show above the frame when hung.
- The longest outside frame dimension cannot exceed 40".
- **If artwork exceeds 30" in any direction, glazing must be plexiglass and not standard glass.**
- Frames in **black wood or metal are preferred**, and should be in new or excellent condition. Colored mats are allowed for this show.
- The OSA commission is 20% on sales. Funds will be collected from buyers and balance provided to artist during art pick-up hours.
- Artist will be notified of any sales.
- If sold, artwork must remain on exhibit for duration of show.
- By participating, you agree to the terms of this prospectus.
