

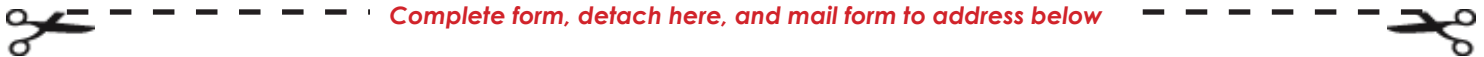
# CPSA DC 201 Chapter Membership

## Membership Information and Instructions

**IMPORTANT! Chapter Membership Requirements:** You must be at least 18 years of age. You must also be a member in good standing of the national CPSA organization to be a member of a local district chapter. - **Chapter Dues:** Annual DC 201 chapter dues are \$20.00. Dues paid after the new membership year begins on November 1 are not prorated.
- **New Members:** You may join anytime during the year. If you have never been a member of DC 201 and you join between July 1 and October 31, your membership will extend to include the chapter year that begins November 1.
- **Renewals:** Your membership is valid from November 1 to October 31. However, you may renew as early as September 1 for the year that begins on November 1. If you will not be renewing, please notify the chapter membership director (below). **Please renew by October 31.** Members not renewed by December 31 will not receive subsequent chapter newsletters or emails. Memberships lapse March 31.
